

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.28507000 per \$100 valuation has been proposed by the governing body of PARKER COUNTY - GENERAL & LATERAL ROAD.

PROPOSED TAX RATE	\$0.28507000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.28507003 per \$100
VOTER-APPROVAL TAX RATE	\$0.31523300 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for PARKER COUNTY - GENERAL & LATERAL ROAD from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that PARKER COUNTY - GENERAL & LATERAL ROAD may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that PARKER COUNTY - GENERAL & LATERAL ROAD is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 17, 2025 AT 09:00 AM AT PARKER COUNTY COMMISSIONERS COURT, 1 COURTHOUSE SQUARE, WEATHERFORD, TX 76086.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, PARKER COUNTY - GENERAL & LATERAL ROAD is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the COMMISSIONER'S COURT of PARKER COUNTY - GENERAL & LATERAL ROAD at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by PARKER COUNTY - GENERAL & LATERAL ROAD last year to the taxes proposed to be imposed on the average residence homestead by PARKER COUNTY - GENERAL & LATERAL ROAD this year.

Indigent Defense Compensation Expenditures

The PARKER COUNTY - GENERAL & LATERAL ROAD spent \$1,237,913 from July 1, 2024 to June 30, 2025 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under Article 26.05, Code of Criminal Procedure and to fund the operations of a public defender’s office under Article 26.044, Code of Criminal Procedure, less the amount of any state grants received. For the current tax year, the amount of increase above last year’s indigent defense compensation expenditures is \$309,129. This increased the no-new-revenue maintenance and operations rate by \$0.00019400/\$100.
